Important Information

The nominee for the **Executive Committee** will be an Office Bearer of The Port Melbourne Soccer Club. The Office Bearers are President, Vice President, Secretary, Treasurer and 3 committee members.

Office Bearers should bring skills, known-how and professional standards to the Club. A person cannot be an Office Bearer if they are, or become, bankrupt.

Office Bearers are voluntary positions, and will receive no remuneration.

Office Bearers should declare any known or potential conflict of interest, and absent himself or herself from a Board meeting if a conflict of interest arises.

Office Bearers are required to attend Board Meetings which are typically held at the club outside normal working hours on a monthly basis, or more regularly should the need arise.

From time to time Office Bearers are required to attend meetings outside the Board Meetings, which may include sub – committee, game day matches, disciplinary tribunals, fundraising events and other events deemed appropriate by the committee.
